## SECTION 2 - HAZARDS IDENTIFICATION

### Statement of Hazardous Nature

This product is classified as: Hazardous according to the criteria of ASCC Australia.

Not a Dangerous Good according to the Australian Dangerous Goods (ADG) Code.

**Safety Phrases:** S24/25. Avoid contact with skin and eyes.

## Emergency Overview

**Physical Description & colour:** Viscous blue liquid.

**Odour:** Fresh eucalyptus fragrance.

**Major Health Hazards:** irritating to eyes and skin.

## Potential Health Effects

### Inhalation

**Short term exposure:** Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

**Long Term exposure:** No data for health effects associated with long term inhalation.

### Skin Contact:

**Short term exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However product is a skin irritant. Symptoms may include itchiness and reddening of contacted skin. Other symptoms may also become evident, but all should disappear once exposure has ceased.

**Long Term exposure:** No data for health effects associated with long term skin exposure.

### Eye Contact:

**Short term exposure:** Exposure via eyes is considered to be unlikely. This product is an eye irritant. Symptoms may include stinging and reddening of eyes and watering which may become copious. Other symptoms may also become evident. If exposure is brief, symptoms should disappear once exposure has ceased. However, lengthy exposure or delayed treatment may cause permanent damage.

**Long Term exposure:** No data for health effects associated with long term eye exposure.

### Ingestion:

**Short term exposure:** Significant oral exposure is considered to be unlikely. However, this product is an oral irritant. Symptoms may include burning sensation and reddening of skin in mouth and throat. Other symptoms may also become evident, but all should disappear once exposure has ceased.

**Long Term exposure:** No data for health effects associated with long term ingestion.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

**SECTION 4 - FIRST AID MEASURES****General Information:**

Under running water, remove contaminated clothing, shoes and leather goods (e.g. watchbands and belts). Completely decontaminate clothing, shoes and leather goods before reuse or discard. If irritation persists, repeat flushing and obtain medical advice.**Eye Contact:** Quickly and gently blot or brush away product. clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8).

Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Can be slippery on floors, especially when wet.
